APPROVAL OF THE MINUTES

The minutes of the Gypsy Moth Slow the Spread (STS) Foundation Board of Directors' Conference Call on January 9, 2008 were not completed and will be considered for approval at the Board's Annual Meeting in Indianapolis, IN on February 21, 2008.

STATUS UPDATES OF GRANT AGREEMENTS

Ed Holloman discussed the current Grant Reporting Schedule and pending grant award balances and expenditures.





2008 APHIS Regulatory Grant

Ed indicated that all 424's are in for the second round of APHIS grant funds and award letters would go out late tomorrow and should be returned with signatures by February 29th. Ed indicated that all states are up-to-date on all reporting requirements at this time.

Scott Frank informed the Board that Illinois has now hired their Regulatory person and they now have \$9,500 to deobligate for use by another state. Other states that have a need for additional regulatory funds should send in a request for additional funds. Gary Gibson indicated that West Virginia may need some additional funds to cover a 3% salary increase. The remaining funds will go to Minnesota to restore funding that was previously given up by their program.

2007 Forest Service Trapping & Treatment Grant

Ed indicated as of 02/06/08 there is a balance of \$748,508.30 in grant funds available to the states out of the total grant award of \$3,596,450.61 for funding to the states. The overall Foundation budget shows a balance of \$1,827,974.62 out of the original grant award of \$6,104,202.00. Ed requested that States with high balances be sure to get in their requests for drawdowns in a timely manner.

Ed indicated that all states are up-to-date on all reporting requirements at this time.

An intense audit has been conducted on the Foundation's books and Ed indicated that the auditors have been great to work with. Ed noted that the Audit Letters were returned from all States by February 1st as requested. Ed also remarked that the new bookkeeping procedures are working very well.

STATUS OF 2008 PLANNING BUDGET

Donna discussed the fluctuations of this year's STS allocation and indicated that it finally has settled out at \$8.508 million from a high of \$9.113 million and a low of \$6.0 million. This reduction was due to monies being transferred to Gypsy Moth Suppression to meet the current treatment needs caused by unusually high population levels of gypsy moths.

The Operations Meeting cut the original proposed \$10.5 million down to \$8.5 million by switching doses from 15g to 6 g for matting disruption treatments, cutting spring larvacide treatments, and reducing the number of GPS units purchased.

Things have improved with the State match amounts. Since there are 100,000 acres of treatment on Federal lands, States only need to come up with \$2.33 million in match funding to access the \$7 million in Federal funds. This means that we are overmatched by \$100,000 so States have a little cushion if they need it.

However, STS normally shows a 25% match to the Forest Service grant. The Foundation is \$10,000 short in the 25% match to the Forest Service when you take out the work done by the Universities which does not actually go through the Foundation. Therefore, any States that can come up with additional match amounts should submit a revised 424 by February 15th.
