STATUS UPDATES OF GRANT AGREEMENTS

2011 APHIS Regulatory Grant

The total grant award is \$281,429.00. The amount disbursed as of May 4, 2011 was \$63,269.20 with \$33,147.63 pending. The remaining balance is \$185,012.17. IL, MN and WV still have FSR's to submit. And MN still needs to submit their narrative report.

2010 Forest Service Trapping and Treatment Grant

Ed indicated the total grant award was \$7,489,768. As of May 4, 2011, a total of \$3,645.663.33 has been disbursed leaving a balance of \$514,767,81. Given the current budget situation, Donna recommended all states keep 2010 funds that they may have planned to de-obligate.

Final Budget for FY 2011

Donna said that the final budget allocation for FY 2011 is \$10.5 million. The Northeast Area had \$400,000 that Gene and Ed were able to collect by completing and submitting the paperwork quickly. The treatment applications will be covered out of the 2010 grant. Letters are ready to go to Al's Aerial Service. States can submit 424's. We should have award letters by the end of May if Na receives program direction by mid -May. More matching funds (\$250,000) are needed from the states for the 2011 grant.
