APPROVAL OF THE MINUTES

No minutes were submitted for approval.

STATUS UPDATES OF GRANT AGREEMENTS

2011 APHIS Regulatory Grant

This grant has a zero balance and has been closed. All of the funds (\$281,429.00) were disbursed to states. All reports are current.

2011 Forest Service Trapping and Treatment Grant

Disbursals totaled \$2,031,221.80 as of January 3, 2012, leaving a balance of \$1,507,850.73 available to states. On line 36, there is a contingency of \$610,892.47, which is available to offset costs for this coming year. The other sizeable balance is for racemic disparlure (line 24). This bill will come due this spring. All reports are current for this grant.

2012 APHIS Regulatory Grant Update

The Foundation has received an award of \$45,000 from APHIS. An additional \$45,000 is available from APHIS, if needed. None of the states has applied for the money, so far. States should apply for the money if they have incurred personnel expenses that need to be covered. Julie Spaulding said \$90,000 is the current working total and there will likely be more for the full grant period. We should know the level of available funds by early to mid-February. There will be a transition from Joe Beckwith to Julie as the chair of the regulatory committee because the agreement is now at the national level.

FS Budget and Potential Allocation for STS

At this time, \$8 million is the optimistic estimate for the 2012 STS program. This is due to the reduced allocation of \$112 million for the Forest Service, 18 percent less than the 2011 allocation of \$137 million. Donna will work with operations to pare down the current draft budget of approximately \$11 million.

Changes in the trapping structure could help to reduce the budget. Ohio saved 20 to 30 percent by changing the APHIS trapping grid from 2km to 3km. An increase in grid spacing from a 2km grid to a 3km grid would cut the number of traps by about one-half. The Decision Algorithm would continue to function normally. Changing the grid would need to be done across the entire project for uniformity. Patrick Tobin and Andy Roberts compared different trapping configurations and determined estimated costs for these grids: 2 km grid with delimits (\$2.8 million), 3 km with delimits (\$1.5 million), 2km without delimits (\$2.4 million), 3km without delimits (less than \$1 million). Given that we are \$3 million over budget, we should seriously consider changing our trapping grids to reduce the overall budget.
