## APPROVAL OF THE MINUTES

Carl Harper (KY) made a motion to accept the February 16, 2012 minutes with edits. Sherrie Hutchinson (WV) seconded the motion. The minutes were approved.

#### STATUS UPDATES OF GRANT AGREEMENTS

#### **2011 APHIS Regulatory Grant**

This grant has a zero balance. The funds (\$281,429.00) were disbursed to the states. All reports are current.

# **2012 APHIS Regulatory Grant**

Ed indicated several states (IL, MN, VA and WI) need to submit 424's.

Julie Spaulding presented information about a hold on the regulatory funds. Traditionally, funds for eradication costs and egg mass surveys have been outside the line item. Last year the farm bill funded those activities, but that may not occur this year. Osama would like to have a conference call to discuss if we will get \$171,000 or less in this grant. The call will be 10am ET, on Monday.

# **2011 Forest Service Trapping and Treatment Grant**

Ed indicated the remaining balance is \$3,840,846.62. He has one pending request of \$7,393 for IL and one de-obligation of \$27,000 for OH.

Under the planned expenses category, the racemic disparlure has increased from about \$1.7 million to a little over \$2.2 million. Originally, Donna ordered 4,000 kg, with a possibility of accepting 4500kg. However, there were actually 5400 kg available, and the Foundation bought all of it. As a result, the contingency line went up to account for the extra expense. This purchase will increase supplies to the point where we won't need to purchase nearly as much racemic disparlure with the 2012 budget.

Ed indicated that he is waiting for annual summary reports from the states of IA, KY, IL, MN, OH and VA. We will rename this report "Progress Report" to prevent confusion. Submit reports by March 15, 2012.

## **2012 Forest Service Trapping and Treatment Grant**

Gene and Ed are preparing to apply for \$4,584,150. We are now \$3,000 short of cost share, but this is a temporary glitch with MN. States should submit 424 packages.

#### **Networking with NASF**

It's important to network with NASF, particularly states who benefit from STS, such as Missouri, Tennessee, and Pennsylvania to encourage a positive, supportive relationship. Particularly, when funds are shrinking and competition for grant dollars is fierce. Some state

foresters think other pests should receive more funding and the gypsy moth STS program should get less. Gene has attended the NASF meetings the last three years and has presented the gypsy moth STS project as a joint project. When Noel returns we will ask him for guidance on how to encourage continued support from NASF.

Audit findings have determined that indirect rates charged were different from the negotiated rates. This has triggered a new process. It will be necessary to attach the agreement that shows what the indirect rate is to the 424 package.
