STATUS UPDATES OF GRANT AGREEMENTS

2012 APHIS Regulatory Grant

Ed highlighted that the remaining balance was 46 % of the total grant as of August 31, 2012. Ed encouraged states to spend the balance as soon as possible as this grant period ends on September 30th. The current balance is \$78, 552.14.

2011 Forest Service Trapping and Treatment Grant

Ed indicated IN, KY and MN had remaining balances totaling \$84,277.13 as of August 31, 2012. Ed has received final FSR's from IN and KY. MN is expected to deobligate their remaining balance, which will bring the final balance to \$241,652.93. States are reminded that all reports and deobligations were due mid-July.

Eradication Projects funded by FS via STS Foundation

Ed indicated TN had applied for all of their available funds leaving a combined balance for OH and NC of \$91,526.98. This grant period ends on 12/31/12.

Changes at North Carolina Department of Agriculture

Larry congratulated Gene on his upcoming retirement. Gene was a founding member of the Board. He has served the Foundation well and has contributed much in time and skill at managing the books. We will miss him a great deal. Larry received a letter appointing Phil Wilson to the Board of Directors replacing Gene as of November 1st. Effective November 1st the Vice President/Treasurer position will be open.

➤ **Action:** Larry will schedule a meeting to discuss how to handle the vacancy left by Gene's retirement.

2013 Regulatory Grant

Julie said there was no news on the budget. States will likely have about as much activity as last year. Eradication estimates will be available around mid-November. The future of the regulatory committee is unknown, however, there will be a conference call next Thursday. States summed up their contingency plans as follows. VA will keep an employee on quarterly. MN plans to roll regulatory trapping into regular grid and campgrounds might be excluded from trapping. The State will cover compliance agreements. WI will combine regulatory trapping with the regular grid. Full-time staff will pick up compliance work and some work may shift to APHIS. NC will continue all functions with permanent staff. OH and IN regulatory funds have gone directly to APHIS, and these responsibilities will remain with APHIS. IN regulatory surveys have been incorporated into existing surveys. IL will keep their part-time employee on until the end of the year and then roll as much work as possible into existing workloads of full-time staff. WV will tentatively go through the end of September and then will wait and see what funds come through.

Letter to APHIS

Larry discussed the progress on the letter to APHIS, which will outline what the impact of cutting the APHIS funding will be. It will affect the FS and states as well as APHIS. Larry will have it ready in the next week or two. Julie would like a heads-up just before Larry sends the letter.

Post Board Meeting Activities

Larry Nichols provided the following summary of the Executive Committee meeting.

The STS Executive Committee held a conference call on Tuesday, September 18, 2012 to discuss the upcoming vacancy of the office of Vice President/Treasurer of the STS BOD and to select a candidate for this position. Meeting notes from this conference call are attached.

The Executive Committee considered several factors in selecting the nominee for VP/Treasurer. Consideration was given to the workload of this office (see attached file), the easy in which the duties can be transitioned from Gene to the new VP/Treasurer, and the advantages offered by the VP/Treasurer being in close proximity to the STS Administrative Office. After considering these factors, Phil Wilson, North Carolina State Plant Regulatory Official was the unanimous choice of the Executive Committee. Phil was previously appointed by NCDA&CS to represent North Carolina on the STS BOD, effective November 1, 2012. On September 18, I contacted Phil and he accepted the nomination.

During our next (October) conference call, an election for the office of VP/Treasurer will be held. If you wish to nominate yourself or another BOD member for VP/Treasurer, the opportunity for nominations will be provided during the conference call.

The person who is elected as VP/Treasurer will fill the position from November 1 until the annual election of officers is held at our February meeting.
