APPROVAL OF THE MINUTES

STATUS UPDATES OF GRANT AGREEMENTS

2016 APHIS Regulatory Grant

Ed reported a remaining balance of \$13,675.19 for Virginia, as of June 29, 2017. This money has been spent and the paperwork is being processed. All reports are current. Ed indicated states could submit 424 forms for the 2017 grant for the same amounts as in the 2016 grant (\$110,000).

2017 APHIS Regulatory Grant

The ezFedGrants process is underway to acquire these funds. There were a few temporary glitches, particularly with not allowing a person to represent both their state and the STS Foundation in the system. Phil Wilson could not be a signatory for STS because he was a signatory for North Carolina. Larry agreed to be the signatory for the Foundation, and Melody's name was added to the system as a program contact. The system is expected to work with these changes in place.

2015 Forest Service Trapping and Treatment Grant

This grant has a balance of zero and all reports are in.

2016 Forest Service Trapping and Treatment Grant

Ed reported a balance of \$482,837.79 as of June 29, 2017. The subawards to states have an end date of June 1, 2017. All funds should be obligated by June 1, or each state with funds remaining should submit the amount to deobligate by July 15, 2017. Ohio, Virginia and Wisconsin plan to use all of their allotted funds. Indiana plans to deobligate less than \$5,000. North Carolina and West Virginia both plan to deobligate unspecified amounts. Please submit the paperwork to deobligate funds by July 15.

2017 Forest Service Trapping and Treatment Grant

Donna gave an overview of the contents on the spreadsheet. The award received to date is the partial award of \$2,797,275.00 million that was awarded initially. The revision to capture the remaining amount of \$1,917,008.00 million is pending. Ed has the 424 forms for the full amount from all states except Virginia, which is in process of getting their 424 form into Ed's hands. Donna asked the states to review the amounts listed in the revision column of the subgrants section to make sure that they were correct for

each state. She further explained the supplies, equipment and contract sections in the lower half of the spread sheet. Donna had included a contingency line item for Al's Aerial Spraying for an additional \$10,000 for the MD project. It now looks like this money may not be needed. There is also an equipment expense of \$15,000 for the Otis Lab to repair or replace a refrigeration unit to store the disparlure for the Foundation. Noel indicated the agreement will be processed quickly now that he has prepared the justification form for the equipment expense.

Update on MD Contract Protest

A five-year MD contract was awarded to Al's Aerial Spraying in February 2017. Their proposal received the highest technical rating and was also the lowest price. Therefore, it was a surprise when another bidder filed a protest with the Government Accountability Office (GAO). The Forest Service Chief signed an override which allowed the STS MD project to continue. As of June 13th, the protest was dismissed. The GAO dismissed all complaints and the award stands.

The award to Al's was for 100 percent SPLAT, which is a big change from Disrupt II, the standard product used for many years. Both Al's Aerial Spraying and an ISCA representative will be at the summer meeting to review how the project worked. SPLAT will be used for five years unless the contractor makes a change. Study plots will be used to test SPLAT this year. This will help to verify the efficacy of SPLAT. If it turns out that SPLAT was not effective in the study plots, it is possible more data would be required and then potentially we could switch to Disrupt II, but at a significant cost increase.
